Hwy 155-17 Tract Legal Descriptions

Thence: N 00° 14′ 30" E 890.16 feet along the common line between said I. & G. N. R. R. SURVEY and McKINNEY & WILLIAMS SURVEY, same being the common line between said 15 acre and 646.05 acre tracts and generally along a fence line to a fence corner post found for the northeast corner of said 15 acre tract and the southeast corner of a called 80 acre tract of land conveyed to Clarence W. Wicker et al, by a Partition Deed recorded in Volume 597, Page 794, of the Deed Records of Marion County, Texas, said fence corner post being S 84° 47′ 33" E 526.17 feet from a fence corner post found for the northwest corner of said 15 acre tract;

Thence: S 84° 47′ 33" E 150.00 feet along the easterly projection of the occupied north line of said 15 acre tract to a %" iron rod set for the northeast corner of this tract:

Thence: S 03° 22′ 39" W 922.81 feet along a new division line, same being the east line of this tract to a ½" iron rod set for the southeast corner of this tract and the northeast corner of said Mims Water Supply tract, from which a chain link fence corner post found bears N 74° 33′ 35" W 0.89 feet:

Thence: N 65° 39' 57" W 108.40 feet along the common line between this tract and said Mims Water Supply tract and generally along a fence line to the POINT OF BEGINNING, containing 2.599 acres of land, more of less.
