# FM 125-225 Topographic Map







### FM 125-225 Tract Legal Descriptions

Tract 1

That portion of a 155 5/8 acre tract of land situated South of FM Road No. 125, said 155 5/8 acre tract of land being more particularly described as follows:

All that certain tract or parcel of land silvated in the Gounty of Cass, State of Texas, to wit: Being a part of the James B. Patterson Survey, Abstract No 834:

BEGINNING at a stone in the middle of the road on the Northwest corner of Jos B Patterson 320 acre survey from which a pine bears S 20° E, 13 warss, marked C;

THENCE South with the West line of Patterson Survey, 1307 1/4 varas to a gum, stake on NW corner of the D. A Smith 4 3/8 acre tract in the same survey,

THENCE East with the North line of D. A. Smith tract 672 varas a stake in the field on NE corner of same.

THENCE North 1307 1/4 varas to stake on the North boundary line of the Patterson Survey from which a post boars S 55° W, 17 varas marked X S C, a small pine bears N 35° W, 3 varas, marked X:

Thence North with the West boundary of Lot 3 at 1008 varas the N. W. corner of same in South boundary of Jas. B. Patterson 320 acre survey, a stake from which a red oak 17 inches in dia. hfs. S. 47 deg. E/10 vrs. mkd. 2; a hickory 42 inches in dia. brs S 46-1/2 deg. E 10 vrs. mkd. 3;

Thence West with the South boundary of said Patterson survey at 553-1/3 varas a stake from which a pine 18 inches in dia. brs. S. 72 deg. W 25.9 vrs.mkd. 1; an other 7 inches in dia. brs S 74-1/2 deg./ E.6.1 vrs. mkd. 2;

Thence West with South boundary of said Patterson at 553-1/3 varas the place of beginning, containing 197.6 acres, as described in a deed from G. C. Venable to David A. Smith, dated December 26th, 1883, and as shewn of record in Volume L-2, page 293 of the Deed Records of Cass County, Texas, save and except 50 acres deeded to W. A. Hall, as shown in Volume C-4, page 594 Deed Records, Cass County, Texas, and 47.6 acres deeded to Carl McInvale, as shown

in Volume L-5, page 264, Deed Records of Cass County, Texas. leaving in this tract 100 acres of land, more or less.

TRACT 3:(

All that certain tract of land situated in Cass County, Texas, situated about Li miles S 55 deg. B from Linden, in the Jas. B. Patterson Survey of 320 acres, State Abstract NO 834, and described as:

Beginning at an iron state on the S.W. corner of said survey, a sweet gum 24 inches in dia. brs S 4; deg. E 12 vps. mkd D. S.;

Thence East with South Yine of said survey 672 varas a stake in center of same survey line, a hickory brs. S 71 deg. W 5-1/4 vrs. Mkd. D. S; a black jack brs. N 83 deg. W 17-1/2 vrs. Mkd. C;

Thence North 36-3/4 varas a stake in field;

Thence West 672 varas an iron stake on the West boundary of said Patterson survey;

Thence South 36-3/4 varas to the place of beginning, and containing4-3/8 acres of land, more or less.
