This Eastern Oregon Ranch was used as a Duck Hunting Club in the late 70's and early 80's and bordering 2 miles at the Malheur Wildlife Bird Refuge. Today the ranch is managed for pasturing cattle and on normal water year can pasture 250-375 pairs from April to October on the deeded land and BLM Permit. The owner has also put up 30-40 tons of Meadow Hay.

The owner also has listed their hay farm separately but could be combined with this pasture ranch making a balanced cattle operation. The owner is currently developing a new set of working corrals and doing some remodeling to the house's kitchen, bathrooms and siding. This is an easy cattle grazing operation.

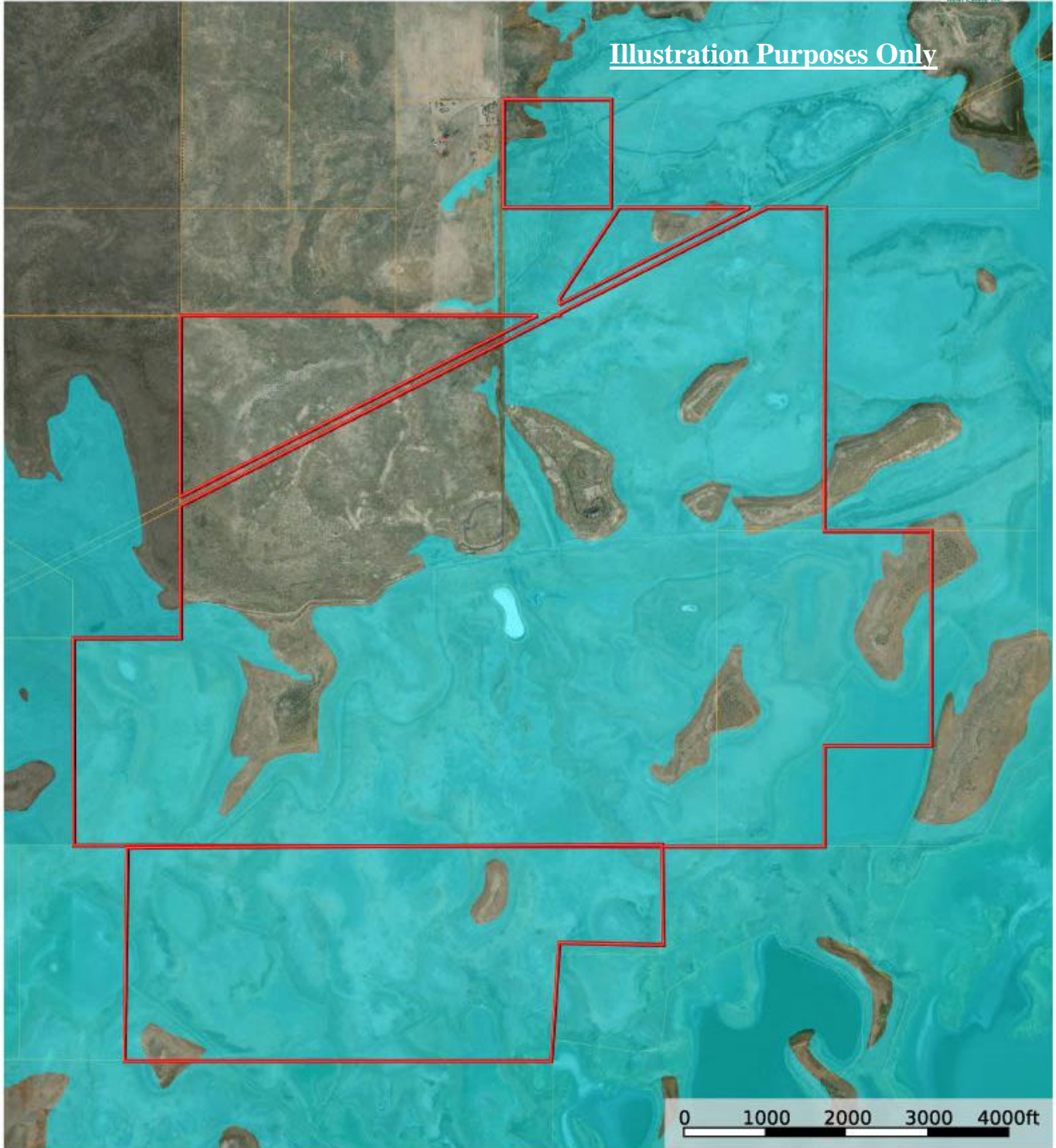

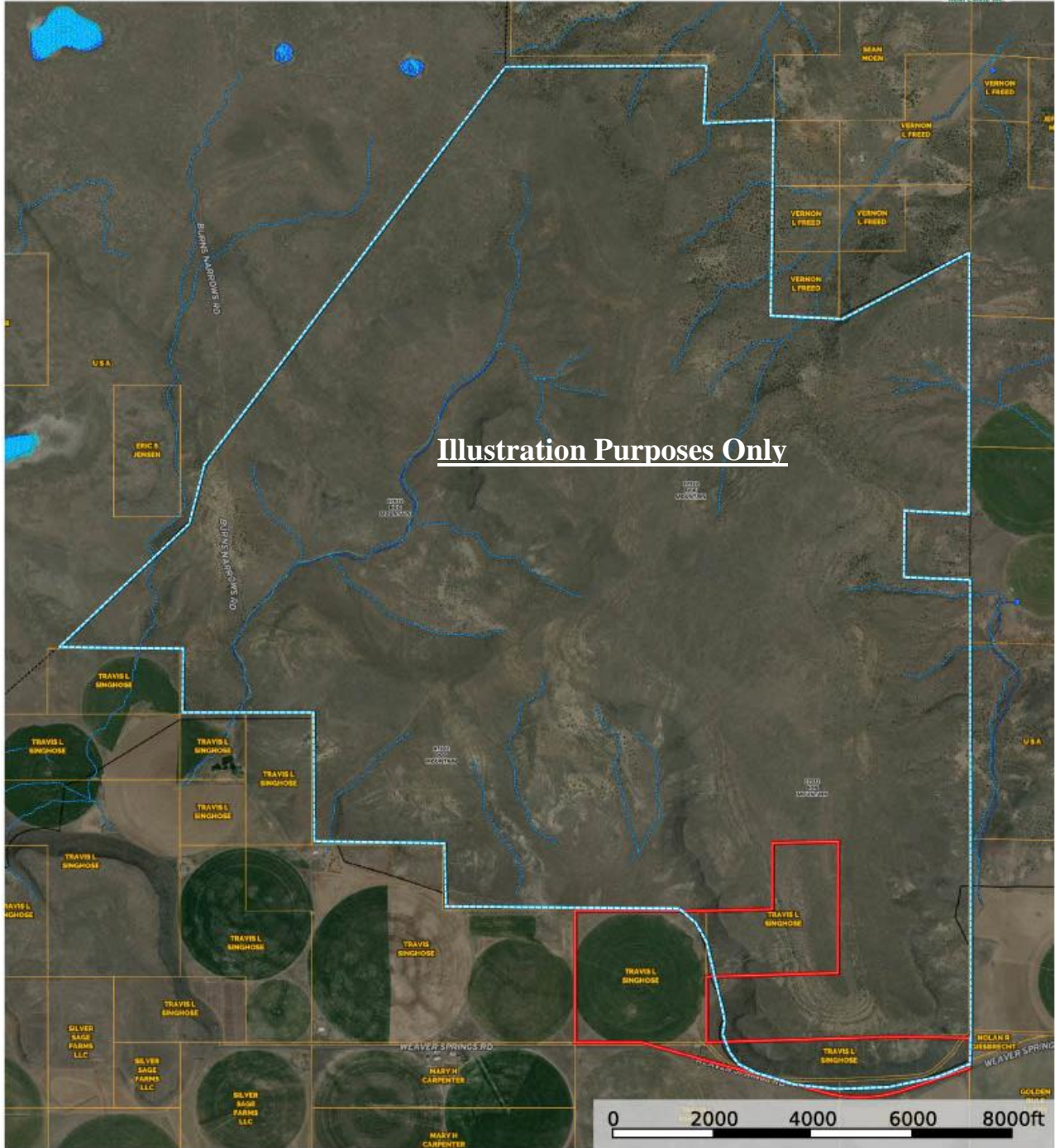

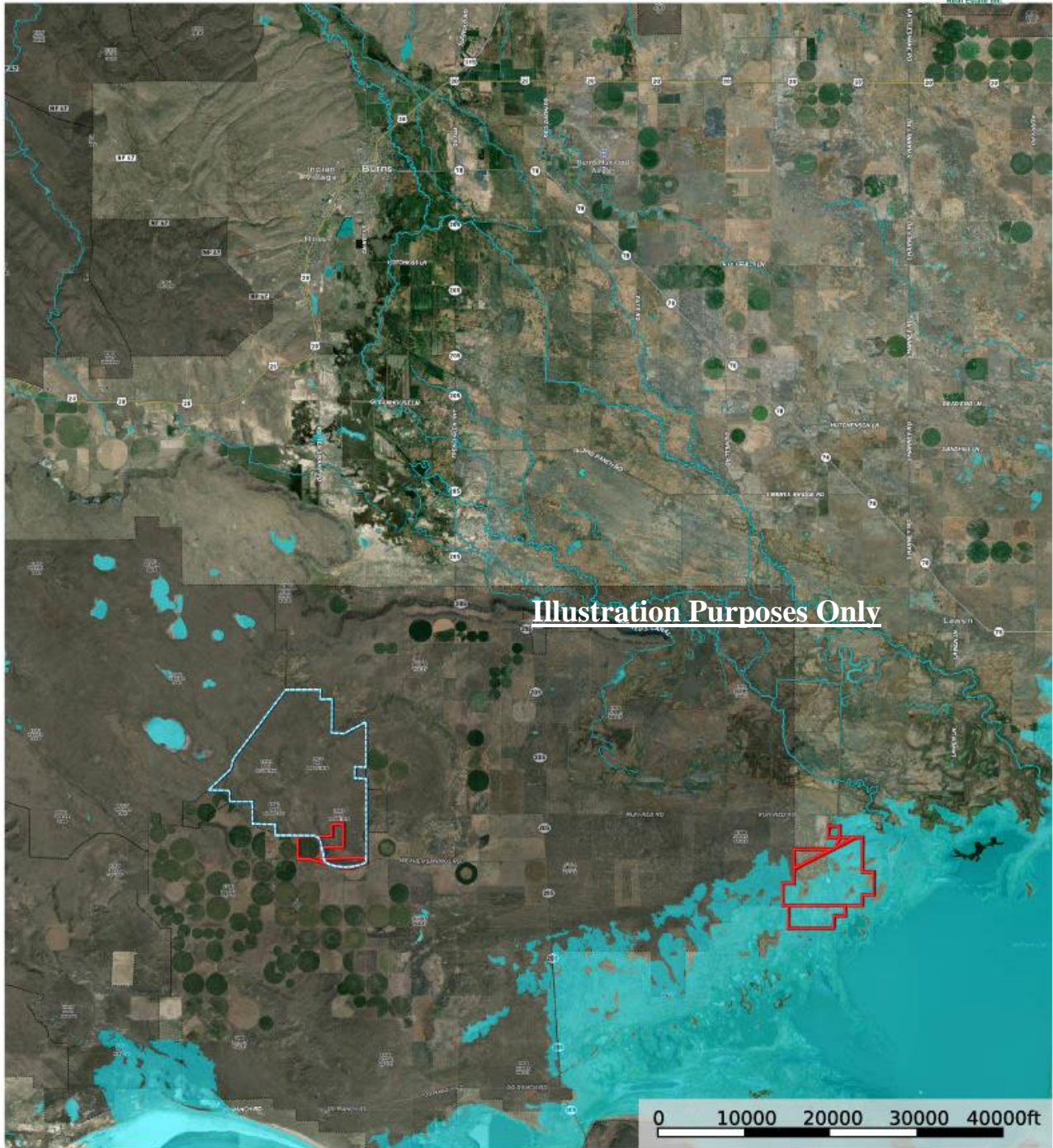

Boundary Boundary Stream, Intermittent River/Creek Water Body

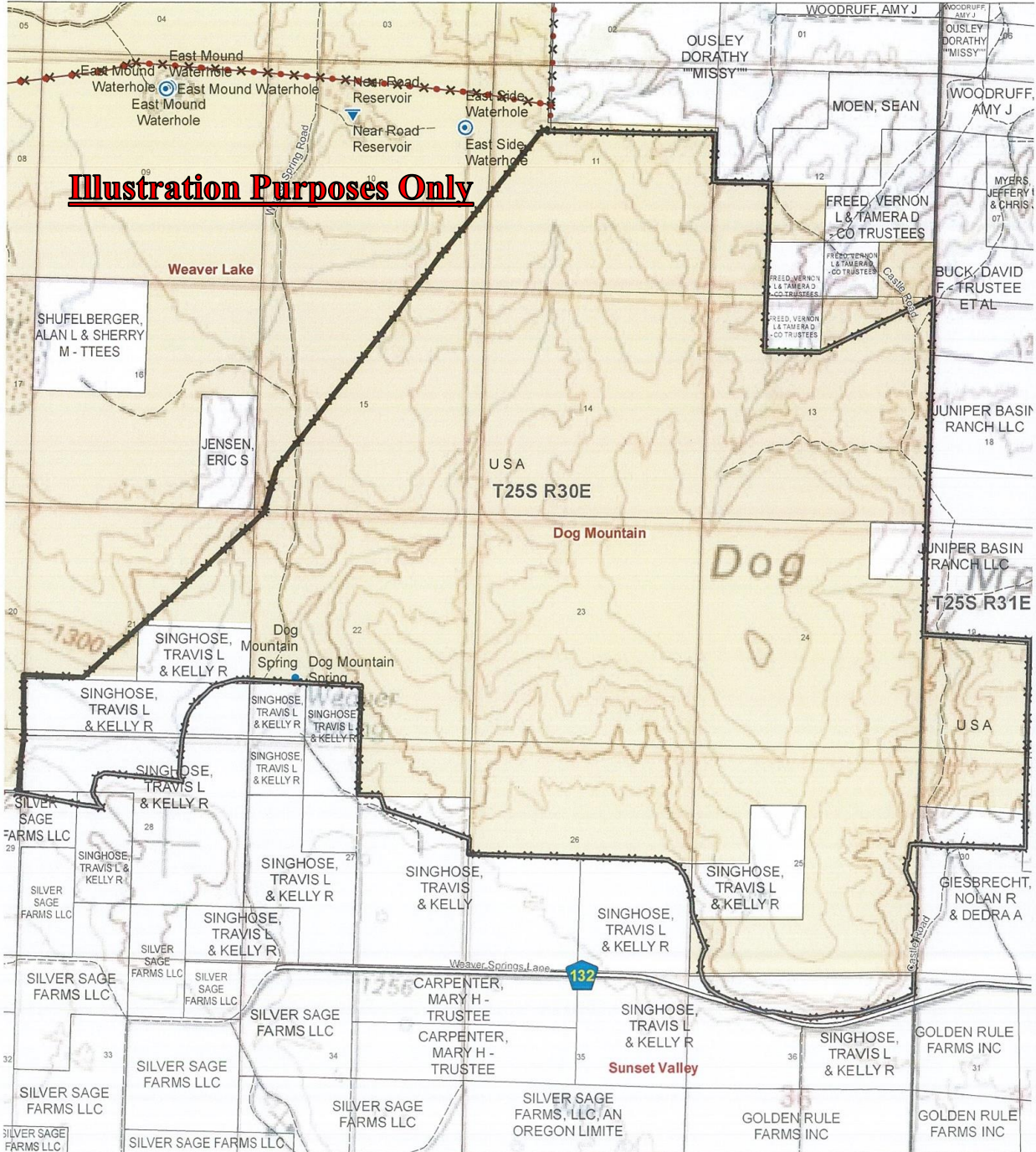
