## FIRST SUPPLEMENTAL DECLARATION AND FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR EMILY'S WALK

This First Supplemental Declaration and First Amendment is made this day of August, 2002 and made effective as of December 21, 2001, by EMILY'S WALK PARTNERSHIP, a Florida general partnership, whose address is c/o Dawson Development Company, 233 East Bay Street, Suite 1010, Blackstone Building, Jacksonville, Florida 32202 (the "Developer").

## RECITALS

- A. The Developer is the developer of certain real property within a planned residential community located in Duval County, Florida, commonly referred to as "Emily's Walk".
- B. The real property located within Emily's Walk is subject to all of the terms and conditions set forth in the Declaration of Covenants, Conditions, Restrictions and Easements for Emily's Walk, dated October 3, 2001, and recorded on December 21, 2001, at Official Records Book 10279, pages 1775 through 1857 of the current public records of Duval County, Florida, as may be amended from time to time (the "Declaration").
- C. At the time of recording of the Declaration, the description of the Property, as set forth in <u>Exhibit A</u> of the Declaration, contained a typographical/scrivener's error. The Developer desires to amend the Declaration, including <u>Exhibit A</u> to the Declaration, to reflect the correct description of the Property.
- D. In accordance with Article XI(H)(3) of the Declaration, prior to turnover of the Association, the Developer has the right to amend the Declaration to clarify the provisions of the Declaration and in such other manner as Developer may deem necessary or convenient. As of the date hereof, control of the Association has not been transferred to the Association.
- E. Article X(B)(1) of the Declaration provides that the Developer shall have the right for a period of thirty years from the date of recording of



the Declaration, from time to time, in its sole discretion, to annex to the Property and to include within the Declaration, other parcels of land (the "Additional Property").

- F. Article X(D) of the Declaration provides that "in the event that any Additional Property is annexed to the Property pursuant to the provisions of [Article X] upon recording of the Supplemental Declaration, (a) such Additional Property shall be considered within the definition of the term "Property" for all purposes of [the] Declaration, and (b) all voting of each class of membership of the Association and all voting by the Owners ... shall be aggregated, it being intended that (i) any voting requirements need not be fulfilled separately for the Additional Property, and (ii) any Class B Member shall at all times have a majority of the votes of the Association until converted to Class A membership as described in Article II" of the Declaration.
- G. The real property described in Exhibit B attached hereto is included within the "Additional Property" definition set forth in Article X(B)(1) of the Declaration.
- H. In accordance with Article X of the Declaration, the Developer desires to develop the Additional Property described in <u>Exhibit B</u> of this Supplemental Declaration as a part of Emily's Walk, subject to all of the terms and conditions set forth in the Declaration.
- NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the Developer hereby amends and supplements the Declaration and declares:
- 1. Unless set forth to the contrary, all capitalized terms herein shall have the same meaning as set forth in the Declaration.
- 2. Exhibit A to the Declaration is hereby amended by deleting the legal description for the Property in its entirety and substituting in lieu thereof the legal description set forth in Exhibit A attached hereto and by reference made a part hereof. All references to the Property shall mean and refer to the land described in Exhibit A attached hereto.
- 3. The definition of the term "Property" contained in Article I(A)(19) of the Declaration is expanded to include the real property described in Exhibit B attached hereto and by reference made a part hereof (the "Phase Two Property").
- 4. The Developer declares that the Phase Two Property shall be occupied, used, sold, conveyed, leased, mortgaged, and otherwise

encumbered subject to the easements, covenants, conditions, restrictions and reservations set forth in the Declaration, all of which are created in the best interests of the Owners and residents of the Property and which shall run with the title to the Phase Two Property and shall be binding upon and inure to the benefit of all persons having and/or acquiring any right, title or interest in the Phase Two Property or any portion thereof.

5. This Supplemental Declaration and the Declaration shall run with the land and shall be binding upon all parties and all persons claiming any interest therein in accordance with Article XI(A) of the Declaration.
