

COVID-19 ADDENDUM/AMENDMENT LISTING CONTRACT

The following provisions supersede any conflicting language in the Listing Contract.

The current world-wide COVID-19 pandemic has had unprecedented impacts on real estate transactions. Listing Broker is seeking to determine Seller's intent to allow or continue to allow showing the property and for continued access to the property by those involved in the transaction process.

In consideration of Listing Broker's continued willingness to market the property under the Listing Contract, the Seller and Broker agree to amend the Listing Contract as follows:

DECISION REGARDING SHOWINGS

Seller makes the following selection and directs the Broker as follows:

Seller authorizes showings or continued showings of the property and agrees to allow access to the property by potential buyers, buyer's agents, inspectors, appraisers, contractors, and others as may be necessary to complete the sale and closing of the property.

Seller agrees to inform Broker immediately if Seller or any person residing within or visiting the property is diagnosed with a confirmed case of COVID-19, or if Seller or any person residing within or visiting the property has had direct contact within the past 14 days with an individual with a confirmed case of COVID-19 (irrespective of whether such party shows signs of sickness).

X Seller elects to have the property noted in the listing service to indicate there will be no showings of the property until authorized by Seller.

List any other related changes, if applicable:

Seller agrees to hold the listing brokerage and its agents, and any buyer's brokerage and its agents, harmless from any and all claims for damages arising out of or relating to COVID-19 concerns or the showing or inspection or availability of the property for showing or inspection during this COVID-19 pandemic.

All other terms and conditions of the original Contract remain in full force and effect.
