**NOTE: New York State Law requires that all taxes must be paid in reverse chronological order, so that the most recent tax is paid first.** When paying taxes on properties with multiple years of taxes owed, you must pay the newest tax first before paying taxes from prior years. If you need further clarification, please contact the Essex County Treasurer's Office at 518-873-3310. Information for taxes prior to year 2000 do not include taxes that were paid to the town collectors.

Tax roll assessments should not be used for current assessment comparisons. Please visit [Real Property Tax Services](#) for the current assessments.

Taxes shown include only *releived* school, water, sewer, etc. School taxes shown are amounts due if paid by September 30<sup>th</sup>. Call school tax collectors for current year school tax amounts due *after* September 30<sup>th</sup>. The treasurer's office collects current year school taxes between November 15<sup>th</sup> through November 30<sup>th</sup> and payments must be certified check or cash. After November 30<sup>th</sup> unpaid school taxes will be relieved to the following year's taxes with a penalty.

For this account, information for taxes in the year 2000 and later include taxes that were paid to the town collectors.

Amounts due that are shown are good only until the last day of the current month.

Tax information for years prior to 2000 is available from the [Treasurer's Office](#).
