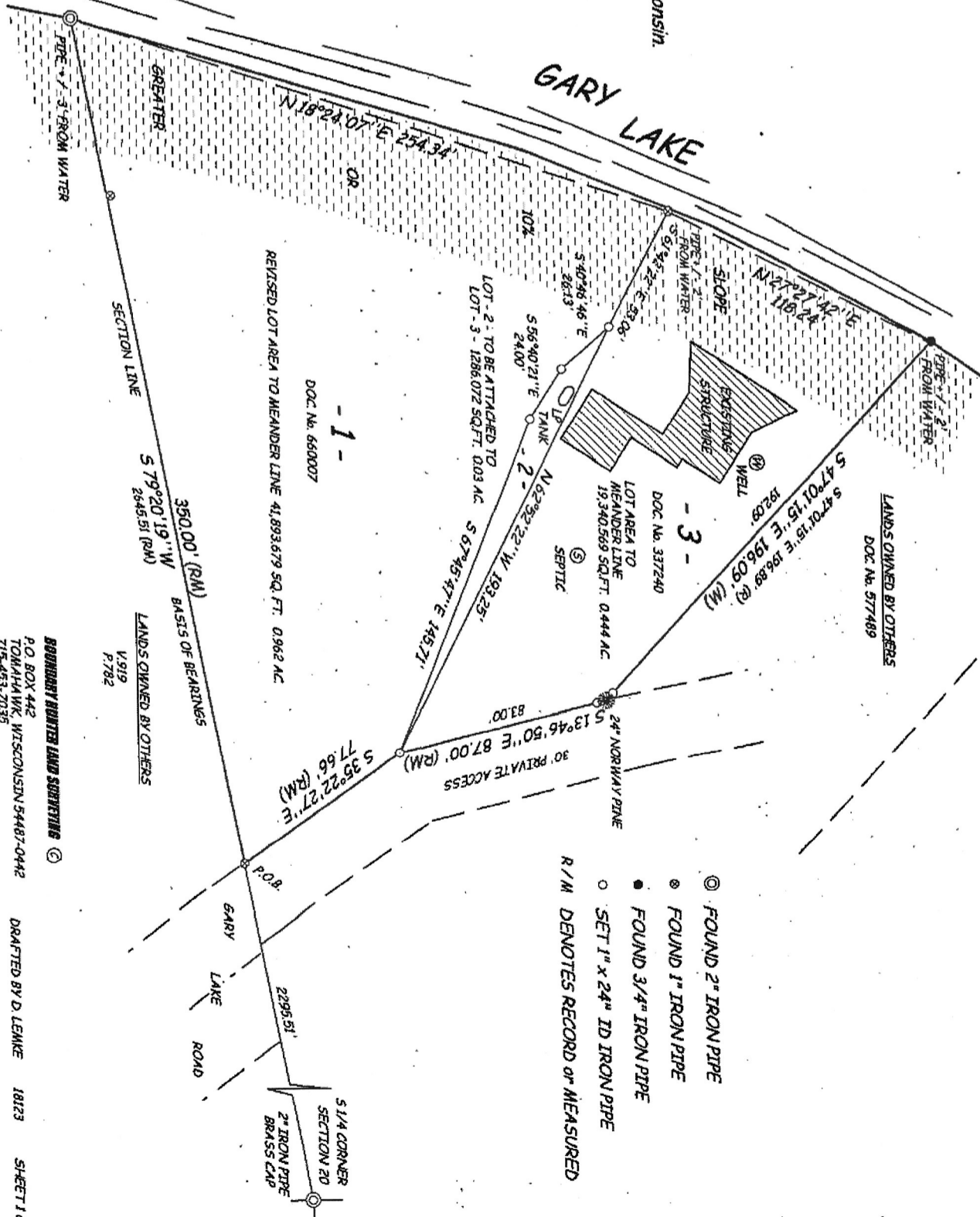
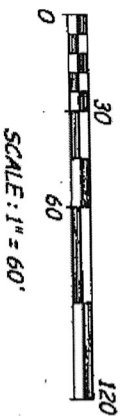
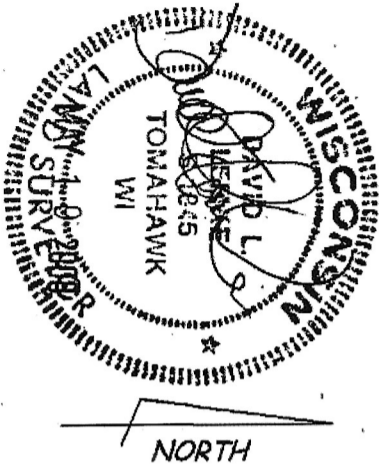

THENCE; CONTINUING ALONG SAID SECTION LINE, S 79° 20' 19" W A DISTANCE OF 350.00 FEET TO A 2" IRON PIPE MEANDER CORNER 3 FEET DISTANT FROM THE SHORE OF GARY LAKE. THENCE; MEANDERING, N 18° 24' 07" E ALONG GARY LAKE A DISTANCE OF 254.34 FEET TO A 1" IRON PIPE 2 FEET DISTANT FROM THE SHORE OF GARY LAKE. THENCE; CONTINUING, N 27° 27' 42" E, ALONG GARY LAKE, A DISTANCE OF 118.42 FEET TO A 3/4" IRON PIPE 2 FEET DISTANT FROM SAID SHORE LINE. 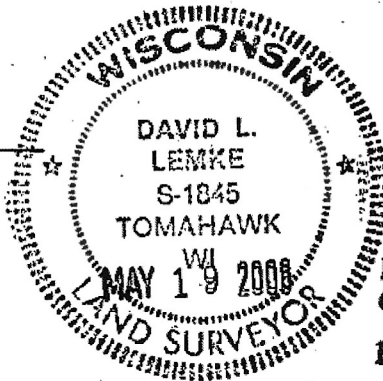
