## **CONDITIONS:**

- Installation of the wastewater system shall be in strict accordance with the controlled demonstration approval CDWS-2006-02, E-Z Set Company and all design parameters submitted by Ralph L. Hollowell, Jr. RS, LSS which are a part of this permit.
- 2. A preconstruction conference shall be required to be attended by the installer, homeowner, Ralph Hollowell and the Hyde County Health Department. Critical points in the installation will be determined at this conference. The installer will be required to give adequate notice to Ralph Hollowell and the Hyde County Health Department for inspection of the critical points, especially the excavation and backfilling where the drainfield is to be located.
- 3. Water tightness of the tanks and any dosing tanks shall be demonstrated by a 24-hour leakage test conducted at the installation site and shall be coordinated by the installer and Ralph Hollowell.
- 4. The E-Z Treat distributor or his/her representative shall inspect the installation and shall provide an acceptance letter to the Hyde County Health Department prior to the issuance of the Operation Permit. Ralph L. Hollowell, Jr. shall provide an acceptance letter to the Hyde County Health Department stating that the system was installed according to his design plans and specifications prior to issuance of an Operation Permit.
- 5. Note Attachment 1 for the excavation/fill/mound construction specifications.
- 6. The mound shall be turtle backed for surface drainage.
- 7. Extablish a grass cover as soon as possible and maintain grass height not to exceed 3"-4".
- 8. The system will require operation and maintenance. An operation and maintenance agreement with a N.C. certified subsurface operator shall be in place prior to the issuance of the operation permit.
- 9. Use water conserving fixtures i.e. 1.6 gallon flush toilets, 2gpm shower heads, 1 gpm all lavatories.
- 10. Note the PME requirements.

### **PUBLIC MANAGEMENT ENTITY REQUIREMENTS**

Effective July 1, 1992, the ground absorption sewage treatment and disposal system serving your facility is required to meet current system management regulations 15A NCAC 18A .1961.

The Hyde County Board of Health has authorized and placed in operation the Hyde County Health Department Public Management Entity. All systems classified Type IV, and V shall join the Hyde County Public Management Entity (PME). According to the <u>Laws and Rules for Sewage Treatment and Disposal Systems</u>, your system classification is <u>Va</u>. A fee of \$300.00 must be paid to the Hyde County Health Department prior to issuance of an Operation Permit for your facility. This fee includes a one-time entrance fee of \$200.00 into the Hyde County Public Management Entity and also an annual fee of \$100.00.

As part of your system management it is necessary for you, the owner, to have an Operation and Maintenance Contract with E-Z Treat Systems. An operator certified in ground absorption sewage treatment and disposal by the North Carolina Water Pollution Control System Operator Certification Commission and E-Z Treat will be provided as part of the contract.

The contract for operation and maintenance with an E-Z Treat certified operator must be signed by all parties involved and submitted to the Hyde County Health Department prior to issuance of an Operation Permit.
