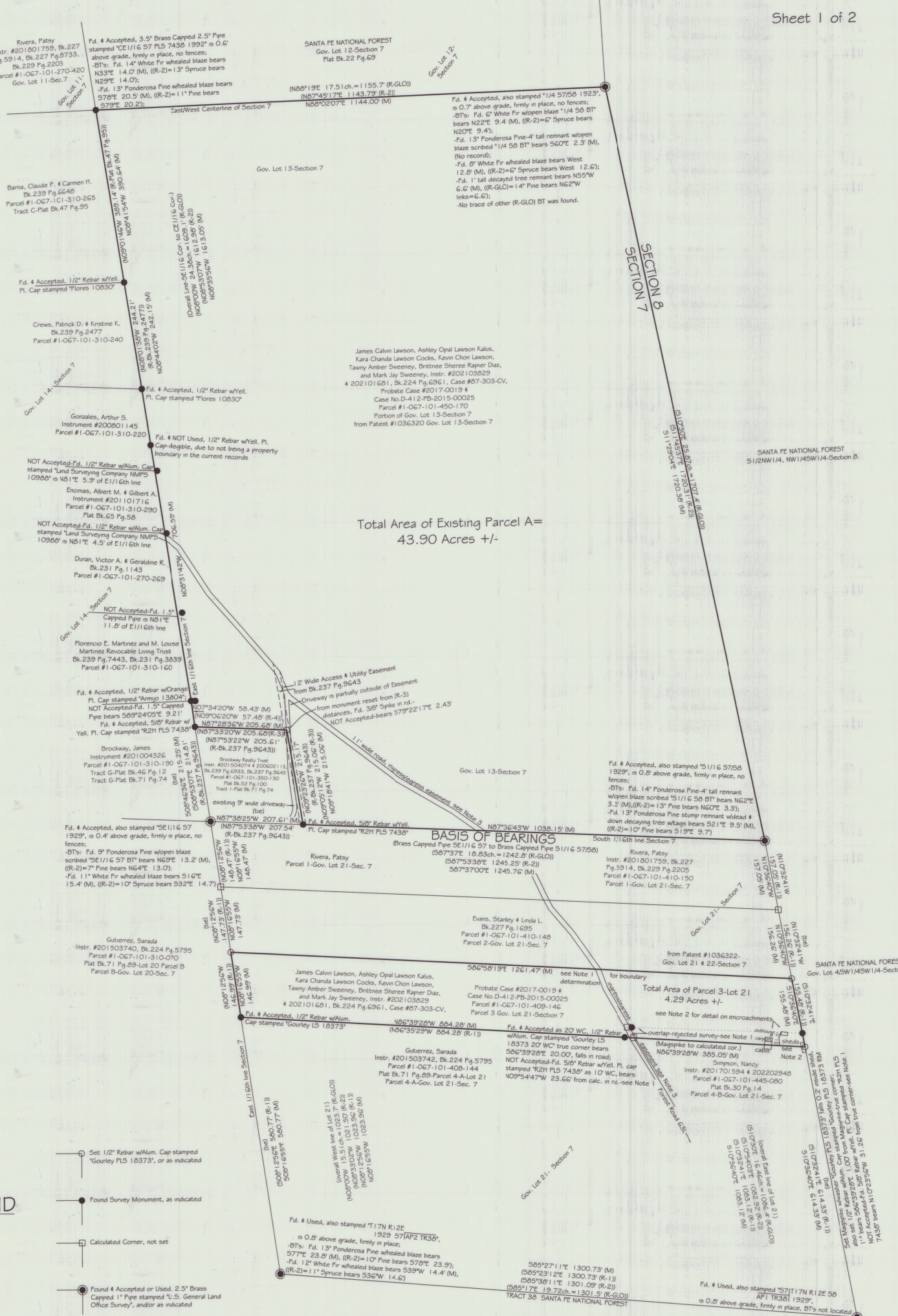

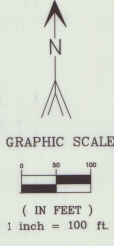
Total Area of Existing Parcel A = 43.90 Acres +/-

Total Area of Parcel 3-Lot 21 = 4.29 Acres +/-

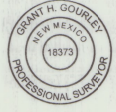
