4 The Managed Forest Law (MFL) is a landowner incentive program that encourages sustainable forestry on private 5 woodland. In exchange for following sound forest management, the landowner pays reduced property taxes. It was 6 enacted in 1985 and replaced the Woodland Tax Law and the Forest Crop Law. It is the only forest tax law that is open 7 to enrollment. Land enrolled in the MFL program must be managed according to a plan agreed to by the landowner.

8 SELLER'S MANAGED FOREST LAND DISCLOSURE: All, or part, of the Property is managed forest land under the 9 MFL. This designation will continue after closing. Buyer is advised as follows: The MFL is a landowner incentive 9 program that encourages sustainable forestry on private woodlands by reducing and deferring property taxes. Orders 9 designating lands as managed forest lands remain in effect for 25 or 50 years. When ownership of land enrolled in the 9 MFL program changes, the new owner must sign and file a report of the change of ownership on a form provided by the 9 Department of Natural Resources and pay a fee. By filing this form, the new owner agrees to the associated MFL 9 management plan and the MFL program rules. The DNR Division of Forestry monitors forest management plan 9 compliance. Changes you make to property that is subject to an order designating it as managed forest land, or to its 9 use, may jeopardize your benefits under the program or may cause the property to be withdrawn from the program and 9 may result in the assessment of penalties.
