- 3. In the event of sale, the owner shall execute the usual sales contract customarily in use in this area which sets forth all details of conveyance.
- 4. If, during this listing period, the property is sold or exchanged through the efforts of the AGENT or the owner, or a third party, or if AGENT produces prospective purchaser ready, willing and able to purchase or exchange for the property or if within two (2) months from the date of expiration of this listing agreement a sale or exchange is made to any person to whom the property has been shown or exhibited by AGENT, the owner shall pay to AGENT a commission of 10% of the sales price.
- 5. Owner shall grant sole authority to advertise the property for sale or exchange, shall refer to AGENT all offers and inquiries he may receive and shall permit and authorize AGENT to show or exhibit the property at reasonable hours.
- 6. Unless another date is agreed upon in writing signed by both owner and purchaser, owner agrees to remove from the transfer possession of property to purchaser on or before the closing date stipulated in the contract of sale.
