

In consideration of the undersigned Manufactured Home Broker's agreement to list and to attempt to effect a sale of the Property herein described, the Owner(s), hereafter Owner, provides RNJ Mhome Connection LLC hereafter referred to as "Broker", the right to sell said Manufactured Home, for the period commencing _11/09/2024__ and terminating at 6 p.m. on_06/09/2025_ or following the sale of the Home, whichever comes first. This Contract may be canceled at any time by the written mutual consent of both parties.

- 1. **TITLE:** Owner warrants that the said Manufactured Home, and all other items made a part of the sale, are free and clear of all liens including, but not limited to, taxes, mobile home park fees, assessments, and ground rental fees. Evidence of title will be furnished in the form of a certificate of title. Any related fees not paid in full prior to the sale will be the Owner's responsibility and will be deducted from the proceeds of the sale.
- 2. **PRICE:** The listing price of the Manufactured Home will be \$ 89,900, of which not less than \$__500_____shall be collected as earnest money from Purchaser, to be held by Broker until date of closing. The selling price will be the price offered by the Purchaser and accepted by the Owner, to be paid as described, in terms accepted by Owner. If any earnest deposit is forfeited it will be divided equally between the Broker and Owner.
- 3. **COMMISSIONS:** If Broker produces a ready, willing and able Purchaser in accordance with this listing agreement and the Purchaser purchases the Manufactured Home, or if a sale or exchange of Property is made by Owner through any other agent or if the Home is sold to the community or mobile home park during the term of this agreement, Owner agrees to pay the Broker a commission of 6% of final sales price. During the term of this agreement, Owner may attempt to sell the home on their own behalf, but may not contract the services of any other dealer, broker, community management, or real estate agent. If the Owner sells the Home to a purchaser that was introduced to the Home or Owner by Broker during the effective period of this agreement, Owner agrees to pay Broker the amount set forth in Paragraph 3. If Owner sells the Home on their own behalf during the effective period of this agreement, Owner agrees to pay Broker the Broker before the consummation of the sale and Broker's commission shall be reduced to three percent (3%).
- 4. **PAYMENTS OF PROCEEDS:** Owner proceeds will be delivered to Owner on closing date. Owner hereby irrevocably assigns to Broker the commissions and/or compensations as set forth herein from Owner's proceeds in escrow or Broker's trust account. If escrow or trust account are not used during the transaction, Owner agrees to pay Broker's commission within two business days of the sale with cash or cashier's check only.
- 5. **MARKETING:** Owner grants Broker the first priority for marketing rights for the Manufactured Home. Such rights include but are not limited to online advertisements, newspaper ads, flyers, and placement of "For Sale" signs. Owner may not place their own "For Sale" sign or other advertisements during the effective period of this agreement.
- 6. MARKETING CONTINUATION DISCLAIMER:

By signing this agreement, the Seller acknowledges and agrees that the Broker may continue to use any photographs, images, or other media of the property for marketing purposes, including but not limited to website listings, social media, and promotional materials. This right shall remain in effect even if the listing is canceled for any reason. The Seller further acknowledges that there is no expiration date for the Broker's right to use these images.

- 7. ACCESS AND LOCKBOX: Access to the home and premises is granted for the purpose of showing to prospective Purchasers at reasonable hours. Unless otherwise stated in this agreement, Owner authorizes Broker to install and use on the property a lockbox containing a key to the property. Owner acknowledges that a lockbox and any other key left with or available to Broker will permit access to the property by Broker and/or potential Purchasers, even when Owner is absent. Owner acknowledges Broker is not insuring Owner against theft or vandalism resulting from such access. Owner also agrees that Broker shall not be liable to Owner for any theft or vandalism occurring at the Home, at any time.

- 10. **EXPIRATION:** If the Manufactured Home is sold within six months after the expiration of this agreement to any person with whom the Broker or any authorized agent has negotiated or shown the home prior to the expiration of this agreement, Owner agrees to pay Broker the commission set forth in this agreement.
- 11. **POSSESSION:** Owner agrees to vacate the Home within 30 days of closing of any sale. Owner may be responsible to pay up to \$100 rent/day to the Purchaser for each day Owner remains in the Home after the agreed upon possession date.
- 12. WARRANTIES BY OWNER ON THE SALE OF THE PROPERTY: (a) CONDITION OF PROPERTY: Broker will not offer any warranty with regard to the condition of the home at any time of sale. All properties are sold as-is/where-is unless otherwise indicated. (b) INFORMATION: Owner understands Broker will be passing on information. Owner warrants information given to Broker to be true.
