

Ridge Pointe Pool Rules

**SWIM AT YOUR OWN RISK - NO LIFEGUARD ON DUTY
SHALLOW WATER, NO DIVING**

Open daily 8AM until 10PM

1. Residents must possess a valid key card and are allowed up to eight (8) guests per household. Residents are responsible for the actions of their guests.
2. Swimsuits required, no thongs allowed. Swim diapers required for incontinent individuals.
3. No smoking, chewing tobacco or vaping material allowed inside the gate.
4. No disruptive behavior, profanity, loud music or public intoxication in the pool area.
5. No roller skates/blades, skateboards, scooters, bicycles or ride-on toys are to be inside the gate. Scooters and bicycles are to be parked in the rack provided outside the gate.
6. All trash must be placed in the provided receptacles or taken home. Any personal items left are subject to being discarded.
7. Return pool furniture to its original setting prior to leaving the pool, close umbrellas.

Individuals that cause the pool to be drained, destruction of property, vandalism, trespassing, or any criminal offense may lose pool privileges, be fined, be prosecuted, and/or may have to reimburse any costs incurred to the community.

Do not prop open the gate.

Exit by pushing the electronic button near the gate.

DHEC POOL RULES

1. THERE SHOULD BE NO SOLO SWIMMING.
2. THERE SHOULD BE NO RUNNING, BOISTEROUS OR ROUGH PLAY.
3. NO PERSON UNDER THE INFLUENCE OF ALCOHOL OR DRUGS SHOULD USE THE POOL.
4. THERE SHOULD BE NO SPITTING OR BLOWING NOSE IN THE POOL.
5. PERSONS WITH DIARRHEAL ILLNESS OR NAUSEA SHOULD NOT ENTER THE POOL.
6. PERSONS WITH SKIN, EYE, EAR OR RESPIRATORY INFECTIONS SHOULD NOT ENTER THE POOL.
7. PERSONS WITH OPEN LESIONS OR WOUNDS SHOULD NOT ENTER THE POOL.
8. NO ANIMALS OR PETS ALLOWED IN THE POOL ENCLOSURE.
9. NO GLASS ALLOWED IN THE POOL OR ON THE DECK.
10. NO CHILDREN SHOULD BE IN THE POOL WITHOUT SUPERVISION.
11. YOU SHOULD TAKE A SHOWER BEFORE ENTERING THE POOL.
12. THIS POOL IS OPEN FROM 8 AM TO 10 PM.
13. THE MAXIMUM NUMBER OF SWIMMERS ALLOWED IN THE POOL IS 30.
14. A FIRST AID KIT IS LOCATED N/A.
15. LIFE SAVING EQUIPMENT IS LOCATED AT BACK POST NEAR FAR END.
16. AN EMERGENCY PHONE (or other notification device) IS LOCATED BESIDE BATHROOM.
17. THE POOL OPERATOR OF RECORD AT THIS FACILITY IS M. HASWELL CERTIFICATION NUMBER 137513.
