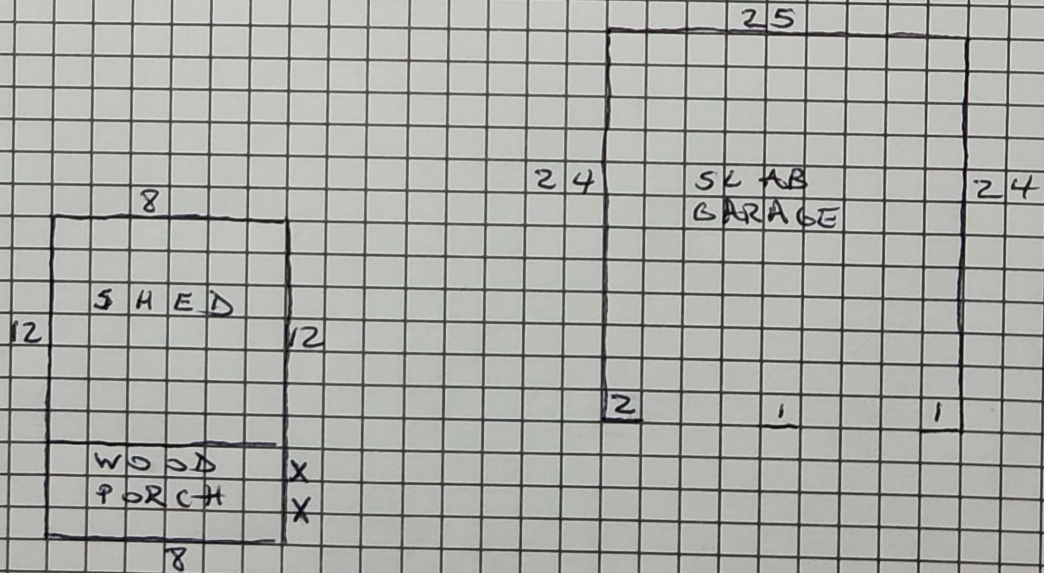

If Statewide Termite Control, Inc. is not notified the contract may be canceled without notice or privilege of reinstatement. Either party may cancel this agreement at any time with 30 days notice.

Statewide Termite Control, Inc. will attempt to schedule an appointment with current home owner on or before annual anniversary date either by phone or written notice. If no response is received within 15 business days this warranty will be terminated without the privilege of reinstatement.
