Property is directly north of the intersection of Hidden Paradise Road and Seven Springs Road.

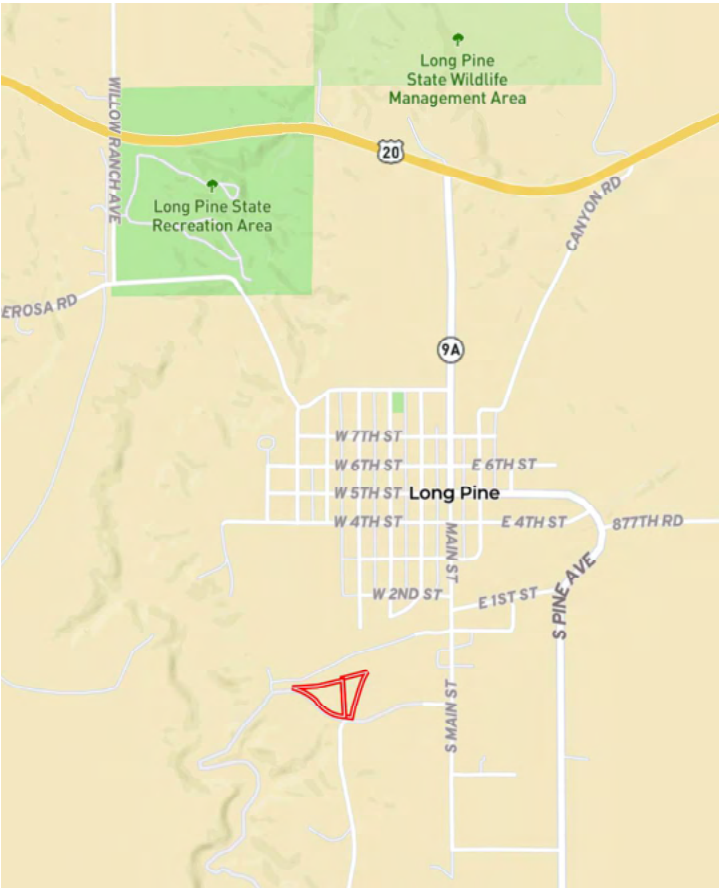
