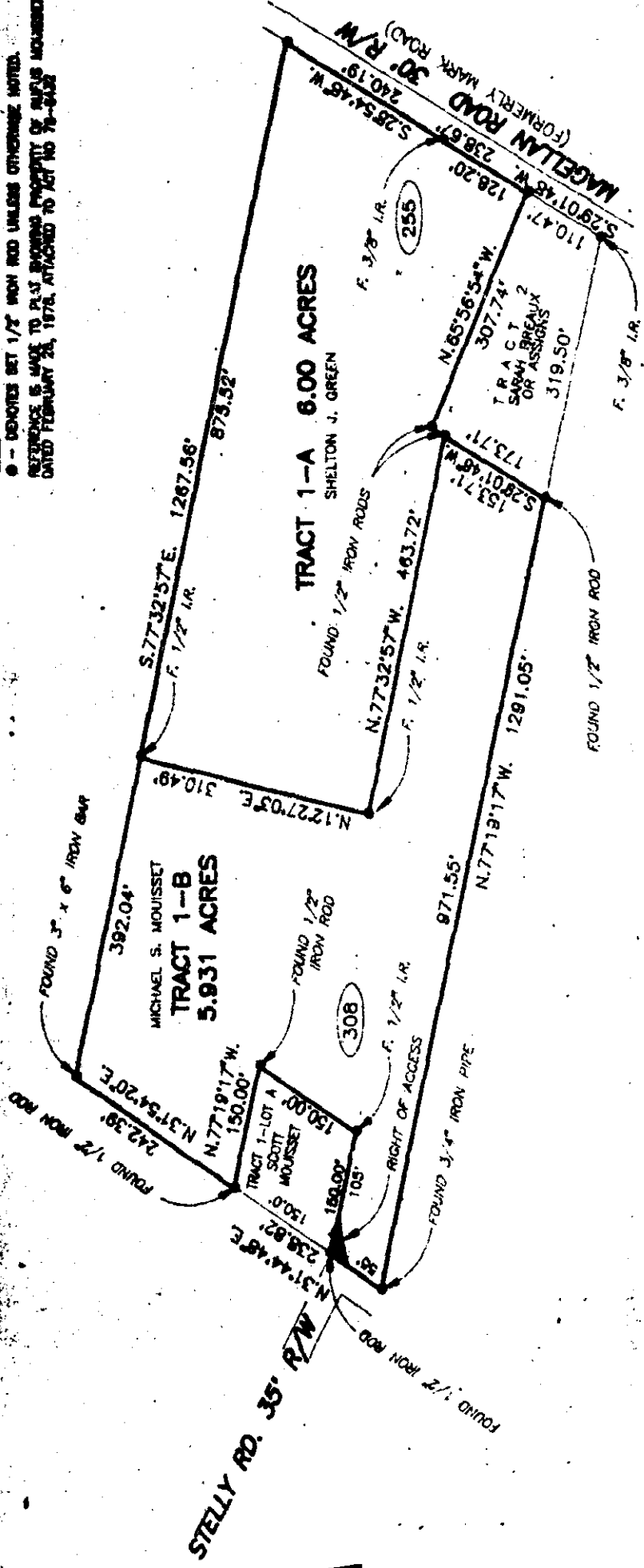

SHELTON J. GREEN & WIFE BARBARA JACKSON GREEN

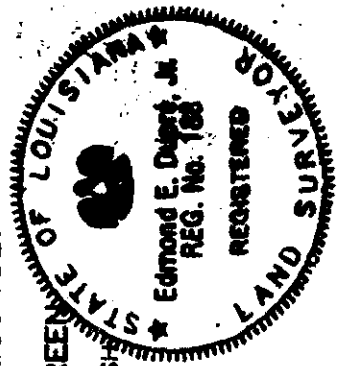

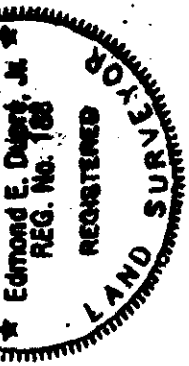

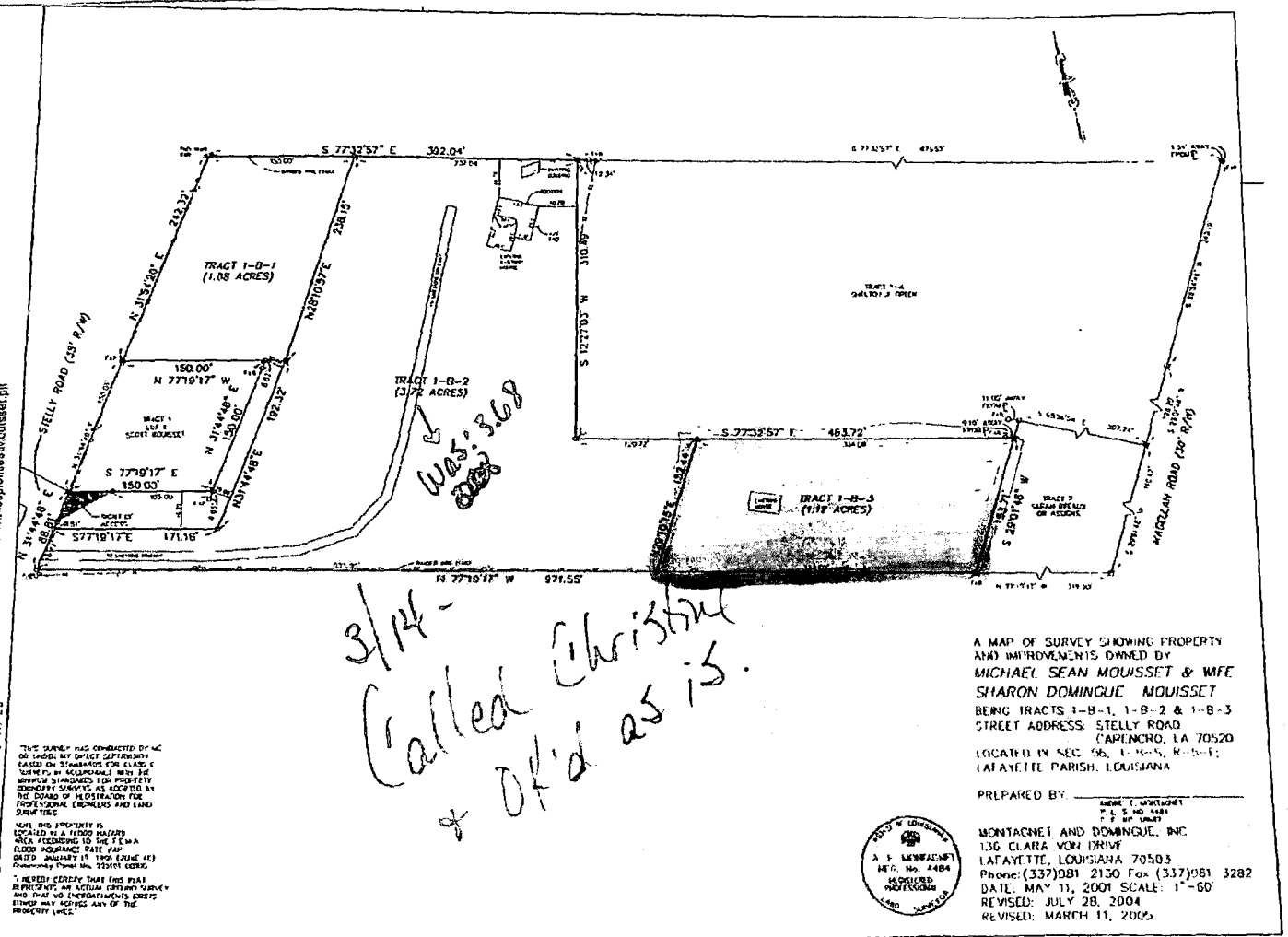
