Seller acknowledges and agrees to the following:

- No showings/viewings are allowed, by anyone including licensee, listing agent, or seller while in Coming Soon status. This includes previews, open houses (broker or public), viewings that are in person, or viewings via the use of any mobile devices, video, social media, or any other electronic means
- Sellers may not view or be notified of any details of an offer until the listing is changed to an ACTIVE status in the Baldwin REALTORS® Multiple Listing Service. Seller has the option to authorize Broker to hold all offers until the expected-on market date as initialed below
- The Coming Soon status requires an Expected On-Market Date. This date cannot exceed 30 days from the date of the signed listing agreement
- If the property is ready to show, market or receive offers prior to the expected-on market date, the listing can be updated to an Active status in the MLS. If no action is taken on a Coming Soon listing, the system will automatically update the listing status to Active status on day 31
- Coming Soon listings will accrue Days on Market (DOM) until the listing status is changed to an Active status in Baldwin REALTORS® Multiple Listing Service and DOM will then reset to zero.
- Advertising or Marketing of the property cannot take place until the home is entered as a coming soon listing in the Baldwin REALTORS® Multiple Listing Service
